Minutes from the March 5, 2018 regular meeting were presented to the board for approval. Crim made a motion to approve the minutes; seconded by Everson. All in favor.

Minutes from the March 14, 2018 special meeting were presented to the board for approval. Everson made a motion to approve the minutes; seconded by Crim. All in favor.

Claims for the city and utilities were presented to the board for approval. The March claims totaled \$1,413,815.99. Everson made a motion to approve the claims; seconded by Roby. All in favor.

An additional claim for Miller Huggins in the amount of \$79.20 was presented to the board for approval. Everson made a motion to approve the claim pending park board approval; seconded by Crim. All in favor.

Utility adjustments were presented to the board for approval. Water adjustments totaled \$2,279.15, Wastewater totaled \$4,772.79, and Trash totaled \$79.58 for a grand total of \$7,131.52. Everson made a motion to accept the adjustments; seconded by Roby. All in favor.

Assistant Fire Chief, Mark Sullivan updated the board on the status of the new ambulance. Sullivan also recommended the board approve the 1986 Boyer Fire Truck be donated to the school for the use of their new fire class. Roby made a motion to donate the truck; seconded by Everson. All in favor.

A contract with Otis Elevator was presented to the board for approval. This contract is for elevator inspections. Everson made a motion to approve the contract for one year; seconded by Roby. All in favor.

An agreement between Miller Huggins and the Elwood Fire Department for copier maintenance was presented to the board for approval. Everson made a motion to approve the agreement; seconded by Crim. All in favor.

Street Superintendent, David Jones requested the board approve a 2018 Silverado purchase from Devoe Chevrolet. Crim made a motion to allow the purchase; seconded by Roby. All in favor.
