This ordinance is for a water rate increase to help fund phase II of the WWTP project. Roby made a motion to read and consider Ordinance 2340; seconded by Wright. All in favor. Ordinance 2340 read title only. Tyner made a motion for unanimous passage on the same night as introduced; seconded by Wright. ORDINANCE NO. 2341 – AN ORDINANCE AMENDING ORDINANCE NO 2170 ESTABLISHING NEW RATES AND CHARGES FOR THE USE AND SERVICES RENDERED BY THE SEWAGE WORKS SYSTEM OF THE CITY OF ELWOOD, INDIANA. This ordinance is for a sewage rate increase to help fund phase II of the WWTP project. Roby made a motion to read and consider Ordinance 2341; seconded by Wright. All in favor. Ordinance 2341 read title only. Tyner made a motion for unanimous passage on the same night as introduced; seconded by Wright. Watters made a motion to vote on Ordinance 2339 roll call vote; seconded by Wright. Roll call: Everson – aye, Moore – aye, Roby – aye, Tyner – aye, Watters – aye, Wright – aye. Ordinance 2341 passed.

ORDINANCE NO. 2338 – AN ORDINANCE AMENDING CHAPTER 95 OF THE CITY OF ELWOOD, INDIANA CODE OF ORDINANCES. This ordinance allows for no alcohol at any park property unless approved by the park board. There was no motion to read and consider. Ordinance 2338 died.

Everson made a motion to adjourn; seconded by Moore. All in favor; meeting adjourned.
