Meeting called to order by Mayor Jones, followed by the Pledge of Allegiance and a prayer. Members present: Kim Everson, Chuck Kane, Linda Moore, Tim Roby, Sam Tyner, Jim Watters and John Wright. Acting City Attorney, Ashley Hopper was present for the meeting.

Jerry Bridges, representing MCCOG, presented an update on the Madison County Comprehensive Plan.

Economic Director, Marcy Fry gave an economic update.

Resident, Burl Tyner asked about the progress on manholes on Main Street. Jones stated the scope of work is finished and it is out for bid.

Bob Collins, 1122 South B St, stated there is a place by the bridge where the road has rose up causing quite the bump in the road. Collins is tired of cleaning the street where debris gets knocked out of trucks. Jones stated to call and the street department will clean it up.

Resident, Tyler Gobble stated he just moved back to Elwood and was eager to help with anything that might better the city.

Resident, Terry Shannon stated that South 24th St. was in bad shape with all of the extra construction traffic. Jones stated he would take a look and try to get it on the list soon.

Moore gave an update on the Chamber of Commerce.

Watters stated the dumpsters at the street department are always full and we need to address the situation. Watters also requested a stop sign somewhere along South D St. from County Line to South 9th St. Jones stated to decide where and bring to council in an ordinance for a vote. Watters also suggested stop signs and speed limit signs be added to Bison Ridge now that it has residents.
