## REGULAR MEETING OF THE COMMON COUNCIL CITY OF ELWOOD, MADISON COUNTY, INDIANA COUNCIL CHAMBERS, MUNICIPAL BUILDING NOVEMBER 4, 2019 7:00PM

Meeting called to order by Mayor Jones, followed by the Pledge of Allegiance and a prayer. Members present: Kim Everson, Linda Moore, Tim Roby, Sam Tyner, Jim Watters and John Wright. Member absent: Chuck Kane. City Attorney, Jeff Graham was present for the meeting.

Christy Clark gave an update on the alley project and the façade program. Clark also thanked Maintenance Supervisor, Mike Delong on the addition of speakers for the alley.

Mayor Jones gave a State of The City address for the year 2018.

Resident, Burl Tyner stated the council was doing a great job and would vote for them if there was an election.

Resident, Bob Collins asked if something could be done about the light on the 28<sup>th</sup> Street car wash as it blinds drivers at night.

Christy Clark stated there is a newsletter going out in the water bill regarding leaf pick up. It will run day after your trash pickup. Clark also stated the Mistletoe Market, parade and downtown lighting will be November 30, 2019.

Moore gave an update on the Chamber of Commerce.

Watters stated the city had collected 622 TV's. The TV's were being taken to Muncie and they will no longer take them. Watters suggested coming up with a way to address the issue.
