

**REGULAR MEETING OF THE COMMON COUNCIL
CITY OF ELWOOD, MADISON COUNTY, INDIANA
COUNCIL CHAMBERS, MUNICIPAL BUILDING
NOVEMBER 03, 2025 6:30PM**

ORDNANCE NO 2455 – AN ORDINANCE REGULATING EXCAVATION OF UNDERGROUND UTILITIES WITHIN CITY RIGHT-OF-WAY AND CITY OWNED OR CONTROLLED PROPERTY. Noone made a motion to table; seconded by Watters. All in favor. Ordinance 2455 passed.


Kelich requested the intersection of South F and South 17th Street be made into a 4 way stop. Graham will draft the ordinance for next meeting.

Watters questioned how individuals on skates or scooters should be treated on the roadway. Watters also questioned who would be at fault in an accident. Graham to review the law and advise.


Watters made a motion to adjourn; seconded by Noone. All in favor.
