

**REGULAR MEETING OF THE COMMON COUNCIL
CITY OF ELWOOD, MADISON COUNTY, INDIANA
COUNCIL CHAMBERS, MUNICIPAL BUILDING
SEPTEMBER 08, 2025 6:30PM**

RESOLUTION NO 2025-13 – RESOLUTION OF THE ELWOOD COMMON COUNCIL APPROVING STATEMENT OF BENEFITS AND GRANTING VACANT BUILDING TAX DEDUCTION FOR DMT RESIDENTIAL DIVISION LLC. This deduction is for 2 years at fifty percent per year. Abernathy made a motion to read and consider Resolution 2025-13; seconded by Noone. All in favor. Resolution 2025-13 read title only. Noone questioned the need for the raises and how it might affect morale.


A special meeting has been scheduled for September 22, 2025 at 5p.m.
